**METERED HYDRANT PERMIT** - This permit shall allow the use of water at a site through a metered fire hydrant connection. Hydrant meter assembly is subject to availability. The meter and connection shall be provided, installed, and removed by Utility personnel only. Hydrant meters will be removed when the possibility of freezing starts. I understand that this permit is issued for my benefit and may be revoked at any time without notice. I will be responsible for any damage to the meter, hydrant, chain, lock or water system. The water obtained from this hydrant is intended for beneficial use and shall not be wasted.

1. Hydrant must be fully opened. Use gate valve to throttle flow. **Shut off hydrant after use each day.**
2. Contractor shall notify the Utility office as soon as the meter is no longer needed.
